DIRECTIONS FOR USE:

1. APEX Micronutrient Formulation may be incorporated for plants grown in soilless media.
2. Reapplication in a single growing season is not necessary unless you are shifting up to a larger container. Please cut back on rate for shifting up in a single growing season.

- APEX Micronutrient Formulation should not be used with any fertilizer that already contains a significant amount of micronutrients.
- The use of soil and tissue testing is recommended to maintain the correct nutrient balance prior to reapplication. Many conditions that appear to be nutrient deficiency may be due to problems such as; pH, cool weather and disease.
- Not recommended for topdress.

- This product is not a replacement for your standard secondary nutrient applications (Ca) and (Mg).
